## **Community Electricity Launching January 2026 in North Kingstown: Will Offer New Choices to Manage Electricity Supply Costs**

North Kingstown, RI - (November 5, 2025) – A new program, Ocean State Community Electricity, is launching for North Kingstown residents and businesses to help manage their electricity supply costs and provide options for renewable energy use. The program starts in January 2026 and interested electricity customers can learn more at one of four community meetings in November and December. The program is being offered to the community via the town's selected consultant, Good Energy, who also manages the seven other active community electricity programs in the state, including neighboring South Kingstown and Narragansett.

The community electricity program will offer three new electricity supply options to all North Kingstown residents and businesses. The program's primary offering, *Standard*, will cost less than the current Rhode Island Energy Last Resort Service supply rate, while also providing an additional 5% renewable energy from RI-based sources.

North Kingstown residents and businesses may also choose from two other options: *Plus*, which has 100% renewable energy, and *Basic*, which meets Rhode Island's minimum standards for renewable energy.

The community electricity program will impact roughly half of a customer's Rhode Island Energy electricity bill by changing the price of the "Supply" section. There will be no impact to reliability, as Rhode Island Energy will continue to deliver the power and to handle all maintenance, including responding to outages. Customers will still receive only a single bill from Rhode Island Energy for all electricity costs. Budget billing and low-income rate discounts will continue without interruption. Similarly, customers receiving net metering or other solar benefits will continue to receive those benefits.

The program is being offered to the community via the town's selected consultant, Good Energy. The launch of the program comes after a local and state approval process. In summer of 2024, the town conducted a public review of its plan for the program. In fall of 2024, the state's Public Utilities Commission approved the plan. The Town Council then authorized the program in February 2025, implemented according to RI Gen L § 39-3-1.2.

Following Rhode Island law, most residential and small business electricity customers in North Kingstown are eligible for automatic enrollment in the program's *Standard*. Specifically, any electricity customer that has not already contracted with their own electricity supplier is eligible for automatic enrollment. The concept behind the law was to provide small electricity customers the buying power on par with large electricity customers.

Importantly, participation in the program is voluntary. Anyone that does not want to participate may opt out without penalty, either before the program begins or at any time during the program. To facilitate this, in mid-November, all customers eligible for automatic enrollment will receive a Notification Letter from the program's chosen electricity supplier, NextEra Energy Services. The letter will start a 30-day consideration period and contain all program details along with instructions to select a different program option or to opt out of the program. The deadline to opt out and not participate before the program begins is December 13, 2025. After that time, you may still opt out, and your request will be processed on your next monthly utility bill cycle.

Electricity customers who currently have an electricity contract with a third-party supplier will not receive the

Notification Letter and will not be automatically enrolled. These customers can voluntarily join the program, but they are advised to check with their current supplier in case it may charge penalties or early termination fees if they leave that supplier during the term of their contract.

The table below shows the prices for Ocean State Community Electricity residential customers compared to Rhode Island Energy Last Resort Service. You can find all prices for residential, commercial and industrial customers at [OceanStateCommunityElectricity.com](https://OceanStateCommunityElectricity.com).

All prices are fixed until your meter read day in May 2026. In early April 2026, the program will announce new pricing to take effect in May. The program will always provide advanced notification of any price change so that participants can make their own choices about whether to continue participation. Currently, residential prices are expected to change roughly every six months, similar to the duration of Rhode Island Energy's supply prices.
