HOMESTEAD EXEMPTION APPLICATION & AFFIDAVIT OF RESIDENCE

The Homestead Exemption provides tax relief to each person who is a domiciled resident of the Town of North Kingstown on or before **December 31st** of each year and which property is the principal residence (owner-occupied) of said person. **The exemption is applied to all residential property with up to 5 residential units.** The exemption shall not apply to mixed use or commercial properties. No short term rentals allowed. You have **until March 15th** of the year the exemption will take effect to apply; otherwise all applications received after the March 15th deadline will be applied to the next calendar year's tax bill.

You are required to provide **THREE** of the following to qualify for the exemption:

- 1) A valid copy of the applicant's Driver's license OR State Issued ID with appropriate address
- 2) A valid copy of the applicant's Vehicle Registration with appropriate address.
- 3) A copy of the first page of your Federal and/or State Income Tax return FILED FOR YEAR APPLYING.
- 4) A current utility bill -,NO sewer/water must show both the service **and** mailing address
- 5) A North Kingstown Voter registration card with appropriate address
