2017 ANNUAL INTERNAL AFFAIRS SUMMARY

COMPLAINTS:

Between January 1, 2017 and December 31, 2017, the North Kingstown Police Department's Internal Affairs Division investigated four (4) complaints of employee misconduct.

Three (3) of the cases originated from citizen complaints. Of those three citizen complaints, one (1) complainant did not file a formal complaint form. Three of the complaints were for alleged Conduct Unbecoming an Officer and one (1) for Simple Assault on a fellow officer. All of the complaints were investigated. Two (2) of the complaints were not substantiated, and two (2) complaints were substantiated.

The North Kingstown Police Department initiated four (4) separate internal investigations. Of those four separate investigations, one (1) was for multiple charges; Criminal Conduct, Conduct Unbecoming an Officer, and Abusive Treatment. One (1) officer was suspended without pay. Four (4) officers received letters of reprimand. All five officers accepted their punishment, one officer received a ten day suspension without pay. Two (2) internal investigations were investigated during the calendar year that did not result in charges. One of those complaints was found to be without merit. The other complaint involved a citizen who has filed numerous internal affairs complaints but does not follow-up on their complaint. The most recent complaint was investigated to the fullest without the complainant's cooperation. There was no merit to this complaint as well.

The following chart depicts the time frame of when the complaints were received, by whom they were initiated, and whether they were substantiated or not.


