STATE WATER QUALITY SURCHARGE EXEMPTION (Age 65 or over)

If you are 65 years old or older you may qualify for an exemption from the State Water Quality Surcharge. To qualify you must 1) be 65 years old or older; 2) be the owner of record of the residence in which you live. Commercial, leased or rental property is not eligible.

The State Surcharge is identified by the SURCHARGE line item on the front of this bill. If this SURCHARGE is not shown, you are already exempt and need not apply again. If you are being charged the Surcharge and qualify for the exemption, please call the Water Department at 268-1521 to request an application form.

Please note: If you have filed a bankruptcy petition and an "automatic stay" is in effect in your case, the Town of North Kingstown will abide by that automatic stay to the extent it is applicable. If you have received a bankruptcy discharge of your water charge obligation(s) to the Town, then the Town does not intend to pursue collection of such obligation from you personally, and nothing in this Notice is, or should be read to be, a demand for payment from you personally. Unless the Bankruptcy Court has ordered otherwise, however, please note that the Town retains whatever statutory lien and other rights it holds under the Rhode Island General Laws in and against the property that secures such obligations(s).
