



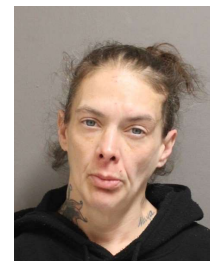

Shoplifting (Felony)

BWC

Synopsis:

Officers responded for the report of a shoplifting suspect being detained. Upon the officer's arrival, and after an on-scene investigation, it was determined that the suspect had shoplifted from the store. The suspect was taken into custody and transported to the station. Upon further investigation it was determined that the suspect had a previous shoplifting conviction and is a violator on two previous cases.

Narrative:

On 03/06/2024, at approximately 0912 hrs., officers responded to Wal Mart, located at 1031 Ten Rod Rd., for the report of Asset Protection personnel detaining a shoplifter. Upon arrival on scene officers spoke with the reporting party Patrick Truman from Wal Mart Asset Protection who relayed the following facts and circumstances.

Truman stated that he observed the suspect, identified as Sandra Beaman, walking in the apparel area of the store picking out items and placing them in reusable shopping bags. As Truman continued to observe Beaman she made her way to the cosmetics area where she again selected several items placing some in reusable shopping bags and some in her purse. Truman continued to follow Beaman as she made her way to checkout and continued to observe her as she scanned one item. Beaman then proceeded to exit the store passing all points of sale. At this point Truman stopped Beaman and asked that she accompany him to his office.

Once back in the Asset Protection office the unpaid for items were removed from Beaman's bags and police contacted. Once tallied the total amount of goods that Beaman had attempted to remove from the store was \$285.07 of assorted clothing and cosmetics. Truman provided a handwritten statement as to his observation and actions during this incident which was later scanned into the report. Truman also provided a DVD of the incident which was scanned into

the image drive in its entirety after which the DVD was destroyed. Also provided was a copy of the receipt for the recovered items which was also scanned into this report. Both the original handwritten statement and receipt were placed in the case folder.

Beaman was placed in handcuffs, which were checked for fit and double locked, and then walked to a cruiser. PO Harris placed Beaman in the prisoner transport compartment which was checked for weapons and/or contraband both before and after transport with none found. PO Harris brought Beaman to the station where she was brought into booking and then placed in cell 28 which was checked for weapons and/or contraband both before and after with none found.

Upon arrival at the station further investigation revealed that Beaman has been previously convicted of shoplifting on 03/20/2023 (case # 61-2022-12150). This information upgraded the current charge to shoplifting felony.

At approximately 1200 hrs. Beaman was removed from cell 28 for processing. During processing several needles with syringes were in Beaman's backpack. Some of these items appeared to be used while others appeared to be new. Some of the needles located were without protective caps. For safety reasons all the located needles and syringes were placed in the Sharps container in the booking area. Beaman was processed without incident although she was difficult and uncooperative at times refusing to provide some information and swearing at officers. Det. DePolito also responded to the cell block area to perform an additional pat down of Beaman prior to transport with no additional items located.

After processing Beaman was placed in handcuffs, checked for fit and double locked and brought to cruiser 211. The prisoner transport compartment was checked for weapons and/or contraband, with no located, and then Beaman was placed inside, and seat belted in. Beaman was transported to the Kent County Court House where she was turned over to the Sheriffs personnel without incident. Beaman had the fifty dollars cash on her person. The rest of Beaman's belongings, backpack, loose change, assorted clothing, and traps, were tagged and placed in a temporary storage locker. It should be noted that due to the needles and syringes located in the property it was placed in a red biohazard bag as a precaution. Beaman was informed that sheriffs would not allow all these items and she would need to respond back to the station upon her release to claim them.

Additional Information:

During both the initial investigation at Wal Mart and the subsequent transport officers had their body worn cameras activated.

As a result of this incident Beaman was also issued a no trespass order for Wal Mart at 1031 Ten Rod Rd. in the presence of Truman.
